That's the name of the game in Sonoma, Sunday, March 26. Come meet your friends and play for the fun of it plus generous cash prizes. .


Here's the Way It Works

THE UMPIRE'S CORNER

it sounds Yeah. unbelievable. But • it really happened. Four of us had a hot game going, when a shooter on a nearby court fouled us up. He shot his cochonnet and it bounced into our playing area. where it hit cochonnet far out of position.

There we were with two yellow cochonnets on the court and nobody could tell or sure which was which—or the correct positions.

In our game, a fierce little argument followed. Nobody came up with a satisfactory solution.

What would be your ruling, Ump?

In a friendly contest, you should pick up either one of the cochonnets, put it back as close as you can to its original position and just go on with your game.

In a strict tournament. however, if the teams can't decide which is their cochonnet, both cochonnets would be ruled dead—as if they were lost. Then, for any scoring, Article 13 would apply. Look it up. This may sound unfair to your game, because it was your cochonnet that was hit away. But unless you marked the position of your cochonnet, that's the way the boule bounces.

This month's question was the kind of thorny, on-the-edge issue that occasionally arises in the game of pétanque. It was a situation that might even be interpreted differently, depending upon the Umpire. The problem described, however, does illustrate the importance of marking the location of the cochonnet and boule in an important match or in a major tournament. It's one way of avoiding controversy.

Revised Format Planned, Summer League Doubles

modified 2000 Summer League Doubles format is in the works that calls for advance scheduling of the opposing teams by random draw—and weekly matches through the summer season.

Developed by the VOMPC Summer League Committee and approved by the board at a special February 12 meeting, the simple format is an attempt to eliminate most of the controversial scheduling and completion problems that have dogged Summer League Doubles in past years.

Weekly matches will be played anytime Sunday through Saturday as agreed upon by the opposing teams. Open weeks will be built into the schedule with no matches assigned—allowing for "makeup" of any matches missed.

Final details of the new format will be released well ahead of the May 19 sign-up date, according to Frank Pipal, who is coordinating the 2000 Summer Doubles program.

No Major Changes In Summer League Singles Program

After a one-year hiatus, Byron Mayo returns to familiar haunts this year as coordinator for the 2000 Summer League Singles program.

Coordinator of the program four different years in the past, Byron is planning an updated version of the format that proved so popular, 1994-1998.

With a start date planned for May 30, all of the details on Summer League Singles 2000 will be available in early May.
